Ann and her husband Dr. Detlev Lange are long time members of the Kern Sierra unit. have served many years as directors and officers. Ann has also represented the Kern Sierra unit to the Back County Horsemen of California directors meeting for many years and participated in programs at many rendezvous. Ann has served as the public lands chair for our unit. As chair she has been the voice for back country stock use at countless meeting, wrote unimaginable number of letters and spent many evening and weekends in public meetings. Ann and Detlev have organized and participated in many Kern Sierra work projects and Ann often was the chief cook and wrangler. Ann also contributed her talents at the national level and represented California as a long time delegate to the Back Country Horsemen of America national board meetings. She organized and led the BCHA Wilderness committee and developed educational material to support that cause as well as writing numerous articles on wilderness for the BCHA national newsletter. To promote a working relationship with and keep the work interests of the Corporation before our local, state and federal officials.
